Title IX Office

Howard University is committed to creating and maintaining a safe, respectful, and inclusive learning and working environment, free from all forms of gender-based discrimination and sexual misconduct. **The Title IX Office responds to all reports regarding sexual assault, sexual harassment, gender-based discrimination and harassment, sexual exploitation, dating and domestic violence, stalking, retaliation, and complicity.** The Title IX Office also educates the University community regarding their rights, resources, and responsibilities under the University's *Policy Prohibiting Sex and Gender-Based Discrimination, Sexual Misconduct and Retaliation* (Title IX Policy) and under Title IX law.

REPORTING

You may make a report to the Title IX Office in any of the following ways:

IN CASE OF EMERGENCY

If you believe you are in immediate danger, or you believe that someone else may be in immediate danger or may present a danger to themselves or others, you should call local law enforcement at 911 or, on campus, call the Howard University Department of Public Safety (DPS) at 202-806-1100.

If you or someone you know is experiencing a mental or emotional health crisis, contact the University Counseling Service at 202-806-6870. After hours, weekends, and holidays, contact the Counseling Service Crisis Line at 202-345-6709

If you or someone you know needs medical attention, call 911 or go directly to the Student Health Center or Howard University Hospital.
